- 2. All excavations (including potholing) within 5 metres in any radial direction of pipelines shall be carried out under strict supervision and direction of an Arrow Energy representative.
- 3. Tracked or tyred equipment weighing in excess of 10,000kg (fully loaded GVM) shall not cross any pipelines without prior approval from Arrow Energy.
- 4. All pipeline crossings shall be at 90° (+/- 5°)
- 5. If works are not completed within 12 months from the date of Crossing Approval, a new application must be made.
- 6. Additional approvals may be required from Landholders/other third parties (where relevant).
