20 Submitters and Identification of Issues

This chapter describes the process used to review and categorise all issues presented in submissions on the EIS. The chapter also describes the approach Arrow has taken in outlining the responses to these issues in this SREIS.

20.1 Categorising Submissions

A comprehensive review was undertaken of the 53 received submissions to classify specific issues raised. Submissions were generally made in two forms - either a letter format, or a tabular submission format which was most commonly used by government departments, councils and the chief executive of EHP. Submissions were reviewed to define individual issues, which were then recorded and assigned an issue number. In total, 1,327 issues were identified from the 53 submissions received. Four submitters identified that they did not have any issues to register with regards to the Project.

Individual submitters S40 to S52 (13 submitters in total) utilised a third party to submit an identical set of 44 issues each. These submissions have been consolidated and responded to as a single submission with 44 issues (i.e. consolidated from 572 issues). This therefore reduces the total number of submission responses from 1,327 to 799.

Arrow's responses to each of the 799 issues are contained within the Submission Responses chapter (Section 21). Arrow's responses to the submission made by EHP and DSEWPaC are provided in the EHP Submission Responses chapter (Section 22) and DSEWPaC Submission Responses chapter (Section 23) respectively.

20.2 Submitter Issue Register

Table 20–1 provides a list of submitters and identifies which responses were generated to the issues raised by each submission. The submission numbers were assigned based on alphabetical order within category groups, i.e. Commonwealth Government, State Government, Regional Councils, business / corporations, non-government organisations and individuals.

20.3 Explanation of Responses

Responses to submitter issues are provided in the Submission Responses chapter (Section 21), the EHP Submission Responses chapter (Section 22) or the DSEWPaC Submission Responses chapter (Section 23).

Arrow has reviewed each submission and summarised the issue of concern, with an appropriate detailed response, grouped by topic. The level of detail required to respond to each submission issue varies. Examples include:

- Where the issue was a statement rather than a specific question or query (and which Arrow has noted), the response was 'Noted';
- Where the issue had previously been addressed in the EIS, an explanation has been provided and a cross reference has been supplied directing the reader to that particular EIS section; and

- Where the issue required further information, this was provided either:
 - Directly in the submission response table included as part of the Submission Responses chapter (Section 21), the EHP Submission Responses chapter (Section 22) or the DSEWPaC Submission Responses chapter (Section 23);
 - Directly in the submission response table and where further information was required, the response provides reference to the appropriate section in Part A of this SREIS; and
 - Where additional technical studies were undertaken to adequately respond, these have been referenced in Part B (the submission responses), summarised in Part A (chapters), and any technical studies conducted are provided as appendices in Part C (technical studies).
