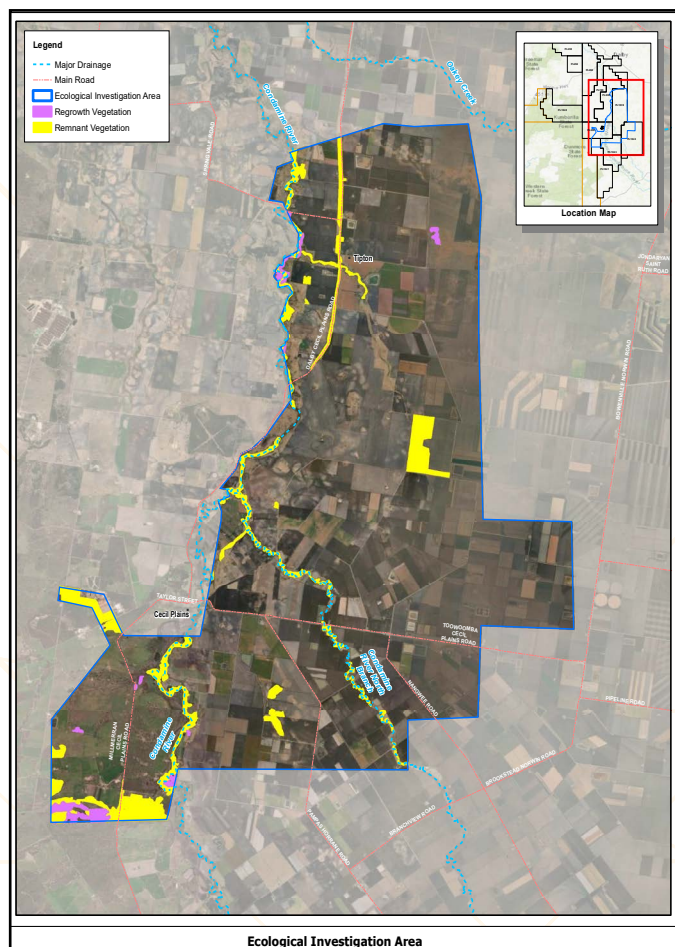
Ecology surveys east of the Condamine River

Arrow Energy is planning to do ecology surveys east of the Condamine River in 2023.

The surveys are a requirement of the environmental approvals state and federal governments have set for the Surat Gas Project. The work will help identify fauna and flora in the area, including any native species and vegetation that should be protected.

Survey details

A small team of independent environmental specialists will make the surveys over seven days in April/May 2023.

We will also do a longer-term study of ground-dwelling reptiles (such as the Condamine Earless Dragon) between January to December 2023. This will involve placing tiles in potential habitats to act as artificial shelters for recording purposes and monthly physical monitoring.

The two surveys will target areas:

- that have been identified as containing threatened ecological communities or are core habitat for threatened species
- where limited ecological information is available
- where more work may be needed to fulfil Arrow's environmental commitments.

What you may see

Surveys can involve on-the-ground activity to identify threatened animals and plants and confirm vegetation community mapping that's been done previously. There may be some night-time spotlighting for nocturnal animals.

Generally, a small team of ecologists will be in any given area for one to three hours. They will revisit the artificial shelter tiles each month.

Environmental approvals

The surveys are required under Arrow's approved Environmental Impact Statement for the Surat Gas Project and environmental approvals awarded by state and federal governments.

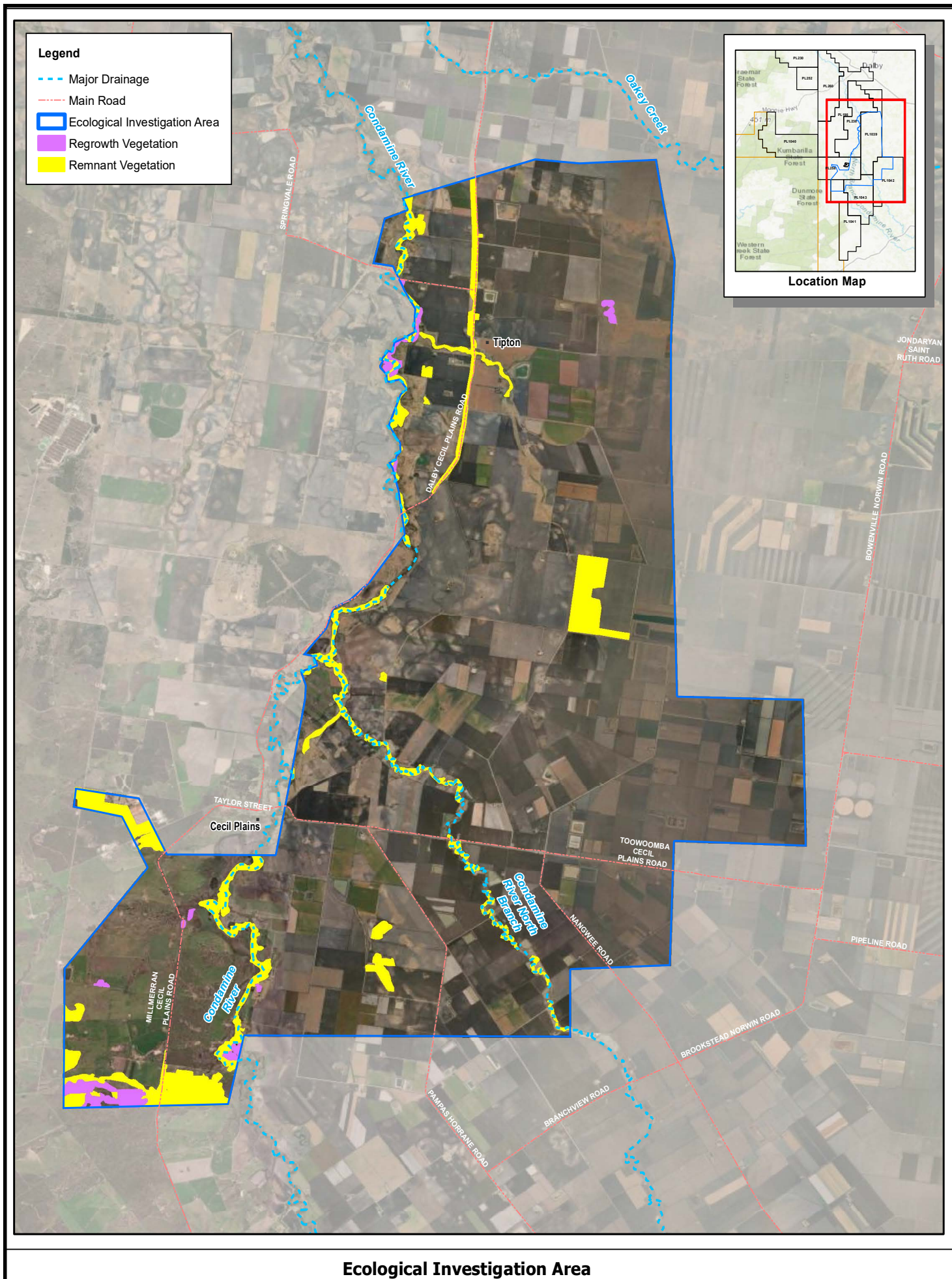
