Arrow's Brighter Futures program offers the opportunity for eligible groups to apply for financial support for activities that make a positive contribution to communities within Arrow's Surat Gas Project area.

The program targets initiatives that focus on:

- Increasing access to educational and learning.

Healthy Lifestyles

- Supporting healthier and safer communities, including welfare and wellbeing services.
- Boosting participation in community sporting and recreational activities with positive community benefits.

Caring for our environment

- Protecting our natural environment to help create a more sustainable future.

Arrow also strongly encourages initiatives delivered by First Nations Traditional Owner Groups, particularly those within Arrow's project area.

About Brighter Futures

There are two types of funding categories available for application under Brighter Futures – grants and sponsorships.

Community grants

- Our grants program provides community organisations, educational facilities, not-for-profit organisations, clubs, associations, and charities with the opportunity to apply for grants of up to \$5,000 (excl GST).
- **Applications open on 9 February 2026 and close on 27 February 2026.**

Sponsorships

- Our sponsorship program supports community events and initiatives.
- Funding applications can be made at any time throughout 2026, with successful sponsorships provided at Arrow's discretion.

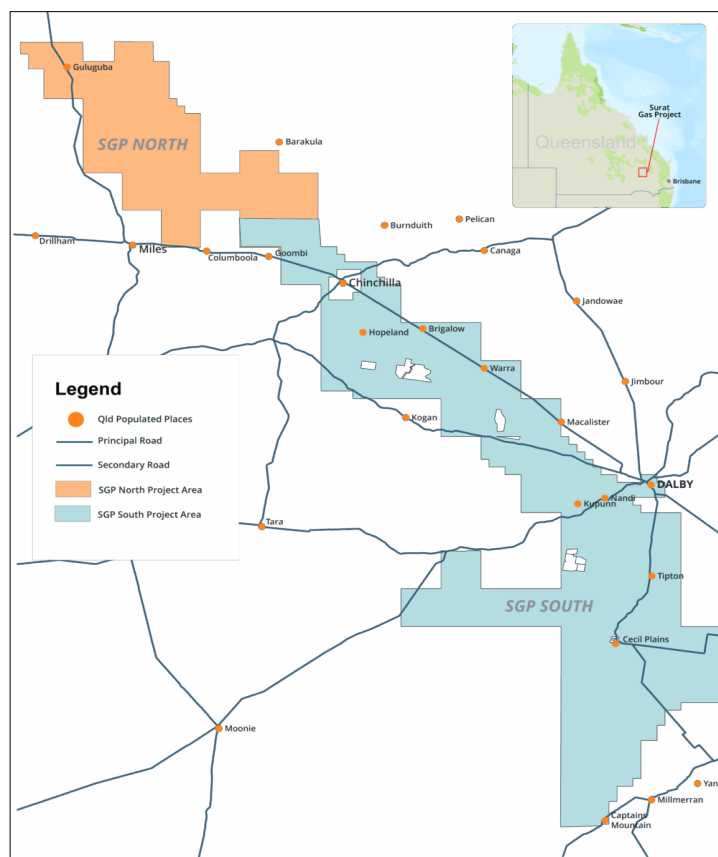

Tips for Success



Plan early – Submit your application well before the deadline.



Be clear and specific – Clearly describe your project, event, or request, including what support you are seeking and why.



Show community benefit – Emphasise how your project will benefit the wider community.



Provide supporting information – Attach quotes, budgets, or other evidence to strengthen your application.



Seek advice – Contact our Community Team before lodging your application for advice.
